

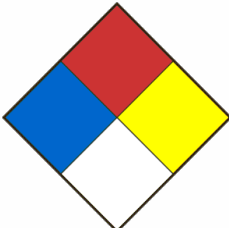

Conditions for safe storage	Hygroscopic. Keep container tightly closed in a dry and well-ventilated place. Keep container tightly closed and store away from heat, moisture, and incompatible products.
Methods of handling	Ensure good ventilation. Always open containers slowly to allow any excess pressure to vent. Avoid formation of dust and aerosols. Avoid ingestion and inhalation. Bottle in glass or plastic containers. Do not bottle in a metal container. NOTE: aqueous solutions are corrosive to metals. Wear personal protective equipment when handling. Always ensure good ventilation. Transport according to TDG (ref Section 14)
